1. Provide all labor, equipment, and material necessary to remove, fabricate, and install new awnings to replace existing awnings on the pavilion and gift shop as shown on the attached photos.

2. Provide all labor, equipment, and material necessary to fabricate and install a new awning and support structure over the double doors on the east side of the gift shop to the edge of the cross walk, meeting with the steps leading to the parking lot.

Bidders interested in this project shall be a legally licensed entity that designs, builds, and installs awnings as a part of its daily business model.

All costs of delivery are to be included in this price. There will be no upcharges allowed for incidental costs to the providing company. Price will be all-inclusive, including any taxes.

This project is time sensitive. It must be completed and invoiced no later than June 30, 2024.

Bids not received by the due date or that do not comply with the minimum specifications will not be considered. Bid Specifics:

1. Replace awning sections in their entirety using the existing structure around the perimeter of the gift shop and pavilion as shown in images #1-15 in Attachment A.

2. Install one new free-standing awning at the location shown in image #2 of Attachment A. This awning shall extend from the double doors to the cross walk intersection (not extending over the cross walk) and be 12 feet in width centered over the double doors on the existing concrete pad. The quality of the posts and support structure shall be equal to or better than the aluminum structure of the existing awnings. Posts shall be anchored to the concrete pad on all attachment points. The height shall be similar to the existing awning but must be high enough for the existing light fixture to fall underneath the awning cover.

The quality of the awning material shall be equal to or better than Sunbrella awning fabric in 6001 Pacific Blue to match the existing blue metal roofing shown in image #16 of Attachment A.


